This competition is the Isle of Man's answer to Britain's Got Talent and is being run by Manx Registered Charity 'Junior Achievement'. **The Next Big Thing** is open to young people aged between 10 to 17 on February 28<sup>th</sup> 2015.

Before filling in your application form please make sure you read the rules on the reverse of this page. Your completed application form must be received by Junior Achievement no later than Monday 20<sup>th</sup> October 2014.

#### **Auditions**

Auditions will be held on Sunday 9<sup>th</sup> November 2014 at Manx Legion Club, Market Hill, Douglas or on Sunday 16<sup>th</sup> November at the Youth Arts Centre, Kensington Road, Douglas.

#### Semi Final

Once the auditions have been completed <u>up</u> to 30 acts will be invited back to take part in a semi final to be held at the Youth Arts Centre, Kensington Road Douglas on Sunday 23<sup>rd</sup> November.

#### **Grand Final**

15 acts will be chosen to take part in the Grand Final at the **Gaiety Theatre** on 28<sup>th</sup> February 2015. The winner will receive a fantastic cash prize of £500 (sponsored by Isle of Man Steam Packet Company). 2<sup>nd</sup> prize is £250 (sponsored by Manx Professional and Educational Services Ltd) and 3<sup>rd</sup> prize is £150 (Hartford Homes).

#### **Rules of the Competition**

#### **General Rules**

- All contestants must be 10 to 17 years old on the 28 February 2015. At the judges request it may be necessary to
  provide proof of your date of birth.
- Acts must be amateurs; professional entertainers are not eligible for the competition
- All acts must reside in the Isle of Man
- Ordinarily each act will be given a maximum of three minutes performance time during the auditions. Bands or specialty acts will be allowed up to five minutes. An official timer will be present and acts will be stopped after the designated time.
- A maximum of two microphones, PA, and CD player will be provided. Applicants must provide their own backing
  music on CD and any other props or equipment required for their performance, it is your responsibility to ensure any
  such equipment is safe and well maintained. No responsibility will be taken for poor sound quality on tracks. At
  auditions bands will be provided with drum kit and amp
- The Competition is open to all performers; e.g. singing, dancing, juggling, magic tricks.
- Each contestant may only enter **ONCE** (in a group OR individually).
- Groups, Choirs or Dance Acts must consist of no more than 15 people. Bands and Groups please note **EACH** registered participant of your group must have their parents' signature authorising their participation.
- All acts aged 16 or under have to be accompanied by at least one adult/guardian
- Any act who has taken first place will not be eligible to compete again for a period of two years.
- By entering the competition you are giving permission for your image to be used for promotional use only
- Only entrants who took part in the original audition will be able to take part in the semi or grand final if selected. No acts must be substituted without the written permission of Junior Achievement
- Proper behaviour is expected at all times from the contestants and the adults accompanying them. Improper behaviour will result in disqualification. This includes poor sportsmanship, bad manners, lack of decorum, approaching judges etc. Disqualification decisions will be made by Junior Achievement staff and are final

#### Acts must be available for the following dates

 Acts must be available for the following: Semi-final on 23<sup>rd</sup> November, Dress Rehearsal on the evening of Thursday 26<sup>th</sup> February and Friday 27<sup>th</sup> February 2015 at The Gaiety Theatre and all day and evening of the Grand Final on Saturday 28<sup>th</sup> February.

#### The Performance

- No props are permitted in the presentation unless they are absolutely essential to the talent performance. Any props
  are the responsibility of the contestant and must be ones the contestant can carry on and off the stage without the
  assistance of another person. No other person can be used as a performance prop, unless part of the group
  division. This does not apply to musical instruments essential for the performance
- · Coaching from off stage, in the audience, backstage or during a performance to assist any contestant is prohibited
- All Acts must be safe and appropriate for general audiences. Acts involving baton-twirlers or similar acts using batons, machetes, knives etc, will not be accepted. No fire, smoke or smoke-effect will be allowed on stage at any time
- Judges are not allowed to discuss contestants and/or acts with anyone other than those on the Judges panel.
   Please do not approach judges for explanations regarding their decisions

#### **Semi Final and Final**

- Acts reaching the grand final can extend their act up to five minutes. As we are unable to stop an act during the live show five penalty points will be deducted from any act that exceeds the five minute time limit
- The act and song choice performed in the semi-final must remain the same for the grand final unless it need to be changed due to exceptional circumstances. Any change must be agreed by Junior Achievement.

We regret that due to a large number of applications we will not be able to notify unsuccessful contestants on an individual basis. If you are successful in reaching the semi-final you will be notified by telephone no later than Tuesday 18 November 2014.
